Most classes that are participating in the 2018 Recitals will be asked to perform at the Del Mar Fair. Because of rehearsed choreography, if we do not receive enough “Yes” responses from your class (75% able to attend) then your class **will not** be able to participate. In order to notify each class of its performance status and to inform the Fair organizers by their deadline, we must receive this permission slip by **Saturday, April 14, 2018**. We request that you turn in your permission slip even if your response is “No” in order for us to keep our records straight. Anyone who has not turned in their permission slip by April 14th will be recorded as a “No”. Please remember to give careful thought to your schedule and understand that a “Yes” response now is a commitment to your classmates and teachers. Although required attendance is approximately 75%, CDT instructors will make final decisions based on their choreography.

The fair will provide each performer with a pass that enables them and one adult chaperone to enter free of charge. You will also receive a pass to park in a special performer parking lot near the Solana gate.

Our performance date is **WEDNESDAY, JUNE 13, 2018**; our performance time is **3:00 p.m. - 5:00 p.m.** Dancers **MUST** arrive **no later than 2:40 p.m.** to the **ALBERTSON’S FUNVILLE STAGE**. Keep in mind that the order of the show changes because we combine both recitals.

This is a fun performance opportunity that dancers always enjoy. We hope that you can participate.

PLEASE NOTE: Our ten-month session ends on Saturday, June 23, 2018.
The six-week summer session begins on Monday, July 9, 2018.
